## Board Members Present:

## President's Report:

MARTY REPORTED ON THE LIGHTS FOR COURTS 1-3. DUE TO RAIN AND ADDITIONAL TIME LOST WHEN THE MACHINERY IS NOT AVAILABLE ON A CLEAR DAY, THE COMPLETION DATE PROBABLY WILL NOT BE MET.( 1ST WEEK IN FEBRUARY.) NO CLEAR TIME LINE IS APPARENT.

## Board Reports:

### Treasurer:

NANCY GEORGE REPORTED THAT MEMBERSHIP DUES, PARTY DEPOSITS AND RECYCLING DEPOSITS ALONG WITH APPROXIMATELY \$6,000 CARRY OVER LEAVE US WITH \$11,762.84. PAYMENTS FOR PARTIES, STAMPS, TOURNAMENTS AND RECYCLING WILL BE DEDUCTED FROM THIS AMOUNT. OUR ANTICIPATED CARRYOVER WILL BE APPROXIMATELY \$9,000. DISCUSSION ENSUED REGARDING ANY POTENTIAL PROBLEMS WITH A LARGE CARRYOVER. MARTY AND NANCEE AGREED THAT THERE SHOULD BE NO ISSUES WITH THE ASSOCIATION. SEE ATTACHED FOR STATEMENT.

KATIE BLOOM REPORTED THAT WE CURRENTLY HAVE 520 MEMBERS BUT ONLY 300 HAVE PAID FOR THE NEW YEAR. WE MAY LOSE OVER 100 MEMBERS THIS MONTH, BUT THE NUMBERS WILL PROBABLY REBUILD BY SUMMER TIME.

LISA HOWARD'S HUSBAND DAVE REPORTED FOR HER. UPCOMING DATES WERE PRESENTED: BIRTHDAY CELEBRATIONS (FEB 5 FOR 70'S AND 80'S. FEBRUARY 6, FOR 50,S AND 60'S) CHRISTMAS PARTY IS SCHEDULED ON WEDNESDAY, DECEMBER 7. SUMMER PARTY WILL BE A LUAU THEME AND HELD IN ORCHARD BALLROOM. (DATE TBD.) THE FIRST MIXER MAY BE MARCH 12 FROM 8:30-12. IT WILL BE A ST. PATRICK DAY THEME. ALL OF THE FEBRUARY DATES WILL BE SUBJECT TO CHANGE DUE TO THE LIGHTING SITUATION.
