**Rating Committee:** Craig Fraser reported there were 100 responses so far. The goal of the committee is to have players rate themselves with the USAPA RATING SYSTEM. The committee would like to see the USAPA rating added next to the letter rating on our roster.

Glenise made a motion for the Rating to Committee to continue their work, seconded by Cindy. Motion passed. At the next general meeting, Craig will give us a roster of those players that have rated themselves.

**Charities:** Scott appointed Mona as chair of Charity Committee. Mona will select members of the committee. Her goal is to reach a hundred dollars per month in recycle donations. She will look into the possibility of getting recycle bins for the summer concerts and the proceeds going to our club. Also, she will look into recycle bins for the Pickleball Courts. It was suggested that she contact the city to see if they could help.

**Pickleball 101:** Andrea gave a report on her class and how it would be organized, etc. She would use courts 3 & 6 and the classes will be held from 3:30pm to 5:00pm on the 2nd and 4th Thursday of the month starting on April 10th.
